- 1 Students are required to be present for 30 hours of classroom instruction. Students will be responsible for being on time to class. Books and study guides will be issued.
- 2 All fees should be paid in full on registration date. No MVD testing can be done until all fees are paid in full. Completion certificates will be issued when all requirements are satisfied. Any late fees or bounced checks must be paid in cash, money order or cashier's check.
- 3 Cell phones must be turned off and put away during class.
- 4 Students are allowed to miss two classroom sessions, but must be approved by the class instructor. Students must make up the work they missed and turn it in. If a student misses more than two days, then they are required to re-take the next class available. (NM State Law)
- 5 There will be a \$20 fee for missing a scheduled driving time. If you must miss, call Chamisa School of Driving 24 hours ahead of your scheduled time. It will be the students' duty to call the Chamisa and reschedule another driving time. Have your permit with you when you show up for driving. No one will be allowed to drive without one.
- 6 If a student is in need of additional driving time to improve skills, your test can be delayed. When you schedule your driving test, bring your log with your logged hours of driving. Parents are REQUIRED by NM to supervise 50 hours of driving time with their student.
- 7 100% will be refunded before the course begins. 75% refund after the 3<sup>rd</sup> day of class, 50% refund on the 5<sup>th</sup> day of class, NO refunds after the 5<sup>th</sup> day of class.
- 8 Smoking, drugs, alcohol are strictly prohibited at Chamisa School of Driving or in the school's vehicles. Food and drinks are not allowed in the vehicles. Eating and driving is one of the most dangerous distractions.
- 9 Proper clothing is required for behind the wheel training. No thick sole shoes, high heels, flip flops, pants below the waist or oversized baggy pants allowed. We have learned that this type of clothing hinders driving abilities.
- 10 There is a \$35 replacement fee for lost or stolen Completion Certificates, so please be sure to save them in a secure place.
- 11 Parents: Do not let your student drive alone on a 6 month permit. They must be supervised by a licensed driver that is at least 21 years old, and has had a driver's license for at least 3 years. This is also NM state law.
- 12 Please pick up your students promptly after driving session or after class. It is our priority to make sure all students are safe.
